


Notice of Recent Documentation Changes – March 2013 Updates

As part of WIRB's continuing efforts to streamline its processes and improve its turnaround time, we have recently made the following changes:

• The Board has stopped requiring more than one continuing review report form per approval period; you will only receive a Continuing Review Report Form just prior to the scheduled renewal review of the research.

As a result, you may notice a change to the section of your Certificate of Approval shown below.



In the future, the Continuing Review frequency cited on the Certificate will always match the Site Status Reporting frequency cited.

- Each panel's roster is now provided in a single document. Rather than receiving a roster listing only the members and alternates of the panel the research is assigned to, the roster will list all members of all panels.
- We have discontinued the practice of applying signatures to the Certificate of Approval. Federal regulations do not require a signature on the notification of IRB actions.
- We have restructured the panels. The research for panels 6, 7, 8, 11, 12, 13, and 14 has been distributed to panels 1-5, which now meet twice a week. As a result, the panel number on your Certificate of Approval may reflect a new panel assignment. If your research has been assigned to a new panel, the terms of your study's approval are unchanged.
